

## Seneca Lake Club Fine Schedule

The authority to impose fines for violations is granted by Article V Section 3 of the Seneca Lake Club (SLC) by-laws which states: “The Seneca Lake Club Board shall have the power to enforce these By-Laws, covenants, rules, regulations, and restrictions. The Board may, for good cause, and following an opportunity for the member to be heard by the Seneca Lake Club Board, assess a fine and/or suspend the privilege of the use of any or all Club property from any member for a set period of time if it be deemed necessary for the general safety, health and welfare of the membership. Collection of fines may be enforced in the same way as collection of dues and assessments, pursuant to Article VIII and XI.”

By-Laws, covenants, rules, regulations, and restrictions apply to Seneca Lake Club property owners and their guests. Property owners are responsible for any violations committed by their guests. This policy does not apply to any violations of local, state, or federal laws. However, the Seneca Lake Club Board and all members have the right to report any incident and have said incident handled by the appropriate local, state, or federal agencies.

Nonpayment of fines will result in late penalties and suspension of membership as stated in the SLC By Laws – Article VIII, Section 2.

<p><b>Non-Residential Use</b></p> <p>Properties shall be used for residential purposes only. <p><b>Nuisance / Obnoxious behavior</b></p> <p>No nuisance or anything obnoxious or detrimental to adjoining or adjacent properties shall be maintained on any part of the property.</p>	<p>24 Hours</p>	<p>Warning</p>	<p>\$500 for each additional occurrence</p>

Violations of any SLC Rules & Regulations not listed above; Based on the severity of the violation SLC reserves the right impose fines and/or warnings.			

## PROCEDURE FOR ASSESSMENT OF FINES

A homeowner has 24 hours after notice to cure the violation, unless otherwise indicated above. Some violations, by their nature, do not exist for more than 24 hours. For these violations, notice will be given and subsequent violations of the same kind occurring after 24 hours shall be considered a continuation of the initial violation and shall be subject to a fine. For example, an owner who allows their pet on club property will be given notice of violation. If they allow their pet on club property more than 24 hours after notice, they will be fined each time the pet is found off leash.

A notice letter will be sent to the Homeowner stating the alleged violation and the amount of the fine to be imposed. If the violation is not cured within the time prescribed, the applicable fine will be assessed and will continually be assessed until the violation is cured. All costs associated with notification of the violation will be billed to the homeowner's account, including, but not limited to postage, envelopes, paper, etc.

All members are required to pay fines. Suspension of membership in good standing status is automatic upon failure to pay Club fines when due.
